Our Commitment to Your Privacy

APG understands the importance of maintaining the privacy of your personal and financial information. By entrusting us with your information, we would like to assure you of our commitment to keeping it private. We have taken measurable steps to protect the confidentiality, security and integrity of your information.

Privacy Policy Summary

We may collect information to process your data transactions, to administer your account, to carry out your request for other products and services, and to ensure compliance with any regulations. We have implemented procedures to protect your nonpublic personal and financial information.

APG does not sell, share, or disclose your non-public information to non-affiliated third parties unless permitted or otherwise required by law. We may share such information with affiliates solely for the purpose of facilitating your requests or instructions.

We limit access to only those employees or representatives that need to know the information in order to assist in carrying out your request for products or services. Further, we maintain physical, electronic, and procedural safeguards that comply with federal and state regulations to guard your information.

Our privacy policy applies, to the extent required by law, to employees and representatives that act on the company's behalf. Additionally, we regularly review privacy policies of third parties for administrative services and joint marketing agreements to ensure compliance with appropriate federal and state regulations.

We reserve the right to change our privacy policies and related procedures at any time, in accordance with applicable federal and state laws. Should our policy change, you will receive notification prior to the sharing of such nonpublic information and you will be provided with an option to opt out of the information sharing arrangement.

Cookies

APG may use cookies and other services for analyzing traffic on the Website in order to facilitate the User's navigation on the Website and optimise the technical management, offer the User targeted advertising adapted to their areas of interest and to create visit statistics. A cookie is a small information file saved by a website on the User's computer. This cookie can be re-used during a future visit to the same website.
